# SCIENTIFIC RESULTS ACHIEVED IN 2011. BY IES ASSOCIATES

The year 2011 would be remembered by a number of events. First of all, the Institute of Economic Sciences went through the process of accreditation for the seventh time (previous accreditations took place in 1963, 1973, 1985, 1991, 1993 and 2006). It has been accredited as a scientific and research institute according to the Law on scientific and research activity of the Republic of Serbia. Another event that makes the history of the Institute was the first project granted within the Framework Program 7 (FP7) under the following title: 'Support to Establishment of National/Regional Social Sciences Data Archives (SERSCIDA)'. We are very proud to say that four young associates would be working on the project, which reinforces our strategy to rely on young scientists. We express our congratulations to Bojana, Ivana, Aleksandra and Aleksandar. They are our heroes of the year and we wish them to be successful and achieve tremendous results in the years to come. The third important thing which happened to us was signing the contract and commencement of the two-year bilateral project on "Agriculture, Natural Resources and Economic Growth - Implications on Rural Policy in Serbia and Portugal" which would be carried out in cooperation with our partner institution - The Faculty of Economics University of Coimbra, Finally, the Institute has received the contract extension on the project Regional Research Promotion Program Western Balkans (RRPP) funded by the Swiss Agency for Development and Cooperation. The main carrier of the activities is the Institute for Central and Eastern Europe, University of Fribourg. Within this program, the IES implements two contracts - a research project titled "Macroeconomic analysis and empirical evaluation of active labor market policies in Serbia" and "Local Coordination Unit" - coordination and support to RRPP program in Serbia.

This year, too, we enlarged the network of partner institutions having signed agreements on cooperation with the Institute of Economics in Zagreb (Croatia), The Institute of Economics from Banja Luka (Bosnia and Herzegovina - Republic Srpska), University Center for Managing Conflicts and Organizational Research, Sofia University St. Kliment Ohridski (Bulgaria), Memorandum of Understanding with the University of Economics from Bratislava (Slovakia), and many others. We kept establishing cooperation with institutions at home, having signed Memorandum on Cooperation in the Process of the EU Integration with the Serbian European Integration Office, the Memorandum on Scientific and Technical Cooperation with the Institute for Comparative Law from Belgrade, as well as the Memorandum on Cooperation with a renowned company "AXA Services" from Belgrade.

We have cherished and further developed very intensive regional and international cooperation with our partners and friends throughout Europe. Based on our activities, fair play and above all our results, we try to promote economics not only in Serbia but in the region and wider community as well. Our associates, especially the younger ones, took study trips and expert trainings at Sophia Antipolis University of Nice, France, University of Turin, Italy, University of Saarbrucken, Germany, University of Ljubljana, Slovenia, University of Kosice, Slovakia, University of Coimbra, Portugal and in the region, in Zagreb, Podgorica, Sarajevo, Skopje, Banja Luka, and so on. During the course of the year 2011 the activities have been successfully realized on the international projects, such as 'Master d'études européennes à double diplomation en Serbie' and 'Macroeconomic analysis and empirical evaluation of active labor market policies in Serbia'.

The central part in our scientific and research work during the last year was marked by the commencement of implementation of the three projects funded by the Ministry of Education and Science of the Republic of Serbia. In a research cycle, according to the Ministry program for the period 2011-2014 our researchers are engaged in two macro projects carried out by the Institute, as follows: "European Integrations and Social and Economic Changes in the Serbian Economy on its Way to the EU", "Challenges and Prospects of Structural Changes in Serbia: Strategic Directions of Economic Growth and Harmonization with the EU Requirements" and the one where the Institute acts as one of the partners – "Contemporary Biotechnological Approach in Draughts Problem Solving in Serbian Agriculture". Although it was the first year of the project realization, our researchers have achieved significant results both in quantity and the quality of the papers published in the country and abroad. Five international monographs have been published, as well as five national monographs, over 100 professional papers; our researchers took part in a huge number of national and international conferences and projects and were invited as lecturers. One international scientific conference was

organized, two scientific conferences were held, there was one round table, one seminar, three book promotions, two promotions of the MAP publication and internal education of our researchers has been organized in quantitative methods. One PhD thesis has been defended, as well as two master papers. The two researchers have been awarded the best student award at master and undergraduate studies, and Prof. Mirjana Radović- Marković, PhD has been elected a full member of the World Academy of Arts and Science from the USA.

Since the IES has in its history many decades of ambitious and fruitful publishing activity, during the course of the year 2011 two scientific journals were published "*Economic Analysis – EA*" and "Journal of Women's Entrepreneurship and Education – JWE" as well as Macroeconomic Analyses and Prognoses – MAP, in cooperation with the Belgrade Banking Academy. EA and JWE are indexed in EBSCO, GESIS, ULIBE and DOAJ journal bases and since 2011 they have been categorized M53 on the national list of scientific journals by the Ministry of Education and Science of the Republic of Serbia.

People are our greatest assets. By the end of the year 2011 there were 30 researchers employed with the Institute, from which 13 are PhDs, 6 MScs, 9 Mas and 2 economists. Average age of the researchers is 39. Six researchers have currently been developing their PhD studies at institutions throughout Europe. That is our strength and that gives us hope that the Institute will become even stronger and more powerful institution in the years to come with even bigger and more significant results recognized not only in Europe but worldwide.

In the Bulletin of the Institute of Economic Sciences (IES) we are going to present our activities and events so as to help you gather as complete picture as possible on our results and commitment to scientific research. We would like you to understand that we are an open door house for all coming in good hope, for all who are progressive, innovative people and ideas. We believe that you would enjoy in this publication as much as we enjoyed carrying out all our activities.

# SCIENTIFIC CONFERENCES

During the course of the year 2011 there were three conferences, one round table and one seminar.

#### Scientific conference: "STATE AND PERSPECTIVES OF RESEARCH IN SOCIAL SCIENCES IN SERBIA"

April 14, 2011, Institute of Economic Sciences



Organized by: IES as the local coordination unit of the Regional Research Promotion Program for the Western Balkans.

The Conference gathered representatives from the Swiss Agency for Development and Cooperation (SDC), Ministry of Education and Science of the Republic of Serbia, as well as a considerable number of representatives of the scientific and research institutes and faculties and civic research organizations. It encouraged talks on the position of social sciences, the current challenges and possible development directions.

#### **Conference Outcomes:**

1. Valuation of scientific efficiency

- Lists and grades for evaluation of scientific and research results are necessary, but they should be made more efficient.
- National journals have not been adequately supported in order to be internationally relevant
- Research results are not reflected in defining state policies and strategies
- It is necessary to encourage research results publishing in relevant international journals.
- Rewards should be given to researchers who try to make Serbian science visible at international level.

#### 2. Research

- Put greater emphasis on interdisciplinary research
- Mutual planning and carrying out of research by many scientific and research institutions
- Encouraging research applicable in practice
- Enhancing relations and networking with the researchers and centers abroad
- Improving cooperation between research centers and civic sector.

3. Young researchers

- Defining criteria as of who can be regarded as a young researcher
- Providing opportunities for young researchers to be educated at the most prestigious universities in the world and creating social climate for their come back
- Long-term strategy should involve greater mobility of the lecturers and researchers towards our country, that is introduce lectures in foreign languages
- Providing scholarships for independent research of the young researchers

#### Suggestions for change

- To introduce 'patents' in social sciences
- To encourage translations of scientific papers in foreign languages
- To encourage establishment of the association of the researchers in social sciences
- To make public databases and provide easier access of the researchers to different sources of data
- To co-finance projects of regional importance which would influence the decision-makers in the region
- To envisage possibilities of financing of longitudinal projects and development research
- To encourage gender equality in scientific research

#### International Scientific Conference: "REGIONAL COOPERATION AND EUROPEAN INTEGRATION"

November 7, 2011, International Center for Promotion of Enterprises (ICPE), Slovenia

Co-organized by: Institute of Economic Sciences, Belgrade, Serbia, University of Nice Sophia Antipolis, Nice, France, Scuola di Amministrazione Aziendale, Turin, Italy, Institute of Economics, Zagreb, Croatia, Institute of Economics, Sarajevo, Bosnia and Herzegovina, Institute of Economics, Banja Luka, Bosnia and Herzegovina and Belgrade Banking Academy, Belgrade, Serbia.

The Conference was opened by Dr Štefan Bogdan Šalej, Director of ICPE and Prof. Dejan Erić, Director of IES. Around 20 scientific papers have been presented, classified into four categories: Analysis of the Relations Between WB Countries and The EU; Policy of Equally Spread and Sustainable Regional Development in the Function of the European Integrations, Evaluation of Undergone Transition Changes in Western Balkan Countries; Structural Changes in WB Countries Economy in the Function of the EU Integrations, Restructuring of Enterprises in Order to Achieve Efficiency and Effectiveness; Macroeconomic Framework for Structural Adjustments and Development and Competitiveness of Financial Systems in Western Balkan Countries.

It has been concluded that the continuation of the process of integration of the Western Balkans into the EU requires relations analysis, and the special emphasis has been put on the position of Serbia in the process of euro integration. Not less important are other aspects of the integration, such as environment protection, ecology, sustainable development and other fields of integration. Evaluation of the transition process in the Western Balkans is very important for the analysis of the past, so as to foresee the prospects of these countries in future. It is necessary to make the analysis of these enterprises. Special emphasis is necessary in terms of the analysis of public companies. Also, it is necessary to make a deeper analysis of the financial sector of the Western Balkans in terms of its integration into the EU so as to improve economic growth and development of the Western Balkans.

*Economic Analysis* and *Journal of Women's Entrepreneurship and Education* are issued twice a year in the English language and they are included in Category M53 on the list of national scientific journals of the Ministry of Education and Science of the Republic of Serbia. Macroeconomic analyses and prognoses – MAP, are also issued twice a year in the Serbia language and in the form of abstracts in the English language.



#### ECONOMIC ANALYSIS (EA)

During the year 2011 Economic Analysis got included in one of the most important journal bases – DOAJ. Economic Analysis has become a recognizable journal in scientific circles and it is expected to increase the number of original international scientific papers.

The journal is published in the English language. It is of an international character and all issues are available at the web site of the Institute of Economic Sciences (*Open access journal*).

During the course of the year 2011 the activities have continued planned for the second year of the Tempus project called **"MASTER D'ÉTUDES EUROPÉENNES À DOUBLE DIPLOMATION EN SERBIE**". In cooperation with the Universities of Novi Sad and Niš (with the assistance of the European partner universities on the project), preparation for accreditation of this program in Serbia has started. #### 3. MACROECONOMIC ANALYSIS AND EMPIRICAL EVALUATION OF ACTIVE LABOUR MARKET POLICIES IN SERBIA

The project titled **MACROECONOMIC ANALYSIS AND EMPIRICAL EVALUATION OF ACTIVE LABOUR MARKET POLICIES IN SERBIA"** which in 2010 was selected one out of 8 projects funded by the RRPP program of the University of Freiburg and whose head was Dr Jovan Zubović in the period July 2010 – June 2011 got positive reviews by the representatives of the University and the research has been extended for additional 12 months.

The project is based on the facts that the process of transition and initial reforms in Serbia have not brought positive results in the field of employment. Since the strategy for the reduction of unemployment as well as active policies at the labour market, represent the important instrument for reducing unemployment, the goal of the project is to analyze the effects of the state investments in this field. In this project the model for macroeconomic evaluation of the labour market active policy has been created in order to foresee the best possible social effects for money. The goal of the project in the second year is the evaluation of the influence of the policy of employment on endangered groups, especially women and the young. The research would be carried out on the whole population of the unemployed registered by the National Agency for Employment using the most advanced econometric tools.

• Within the results dissemination on the project **Macroeconomic Analysis and Empirical Evaluation Labour Market Policies in Serbia**, Dr Zubović presented the research results to the team from the Institute of Advanced Studies from Vienna (*Institut für Höhere Studien*).

#### 4. FP7 PROJECT



This year would be remembered as the one in which the Institute got their first FD7 project, being one of the partners at **Support to Establishment of National/Regional Social Sciences Data Archives (SERSCIDA)**.

SERSCIDA has been created as a strategic project for the support, cooperation and exchange of data in the field of social sciences among the EU countries – members of the Council of the European Social Sciences Data

Archives and the Western Balkans countries. The project is intended to evaluate potential of using information and communication technologies for the needs of scientific research and exchange of knowledge in Serbia, Croatia and Bosnia and Herzegovina.

The projects started in January 2012 and it will last 30 months.

The Seventh Framework Program for research and technological development (FP7) is the main instrument of the European Union for funding of scientific research in Europe. Duration of the project is 7 years, from 2007 till 2013. The main aim of the program is to encourage competitiveness, economic growth and employment in Europe through support to priority scientific research fields.

### PROJECTS BY THE MINISTRY OF EDUCATION AND SCIENCE

#### 1. EUROPEAN INTEGRATIONS AND SOCIO-ECONOMIC CHANGES IN SERBIAN ECONOMY ON THE WAY TO THE EU (III 47009, Head: Dr Srdjan Redžepagić)

This is the project within the group of integral and interdisciplinary research which should entail the complex processes of the European integration of Serbia within the EU. The importance and topicality of the project derives from the fact that having applied to become a member candidate at the end of 2009 Serbia formally entered the contractual-partnership relation with the EU. Multidisciplinary character of the project reflects in the symbiosis of economic, legal, political, ecological and some other social disciplines. The project consists of three parts, as follows:

- I subproject (Carried by the Institute of Economic Sciences) entails four themes such as:

   Analysis of the relation between Serbia and the EU;
   Structural changes in Serbian economy in the function of the EU integration 3) Policy of even and sustainable regional development in the function of the European integration;
   Economic and sector policies on the way of Serbian integration into the EU.
- II subproject (Carried by Belgrade Banking Academy Faculty of Banking, Insurance and Finance), titled 'Integration of the Sector of Financial Services of Serbia in the EU' deals with research including: adjusting monetary and fiscal policy of Serbia to the EU rules; comparative analysis of the development of the segments of financial sector in Serbia and the EU; analysis of the degree of integration of the banking system, insurance market and capital market being the three key segments of the financial market; analysis of institutions and financial market instruments; drafting recommendations for integration of Serbia in the financial system of the EU.
- III subproject (Carried by Educons University) titled 'Environment Protection Policy and Sustainable Development of the Way to the EU' entails research and analysis of the following: analysis of the achieved degree of development of the economic and environmental subsystem; goals of environment protection; priorities in environment protection in accordance with the rules and projects by the EU; determining projects in terms of Kyoto protocol implementation mechanisms and raising energy efficiency in Serbia.

During the first year of research, there were 48 researchers engaged who carried out almost all planned activities. It has been published some 189 papers of different kind, from which there have been 11 original scientific papers presented in international journals from the SSCI list (Thompson classification list).

The interdisciplinary character of research as well as the multidisciplinary research teams which engage not only economists, but lawyers, politicologists, agricultural and environmental experts from Serbia and the EU countries, contributed to getting quality research results during the first year of project realization in the form of objective assessment of the current state in the economy and important social segments in Serbia in terms of the EU integration the basis for establishing vision of economic, legal and political steps which Serbia should undertake to reach a higher degree of its integration in economic, legal and political area.

#### 2. CHALLENGES AND PROSPECTS OF STRUCTURAL CHANGES IN SERBIA: STRATEGIC DIRECTIONS OF ECONOMIC DEVELOPMENT AND HARMONIZATION WITH THE EU REQUIREMENTS (OI – 179015, Head: Ivan Stošić, PhD)

The project titled "Challenges and Prospects of Structural Changes in Serbia: Strategic Directions of Economic Development and Harmonization with the EU Requirements" (Code: OI 179015) coordinated by the Institute of Economic Sciences of Belgrade and managed by Mr. Ivan Stošić, PhD, seeks to identify key structural issues of the Serbian economy and to determine directions and the strategy for implementation of the structural harmonization in order to increase national and international competitiveness, increase total development performance and harmonize economic structures with the EU and IMF requirements.

Implementation of this project should provide the following:

- 1) Improve 'state of art' of science in the field of structural harmonization of economy at macro and micro level;
- 2) Ensure collection, systematization and analysis of knowledge on theoretical and practical level in the field of structural changes of the countries in transition, and especially in the region;
- 3) Contribute to formulating science based, theoretical and practical knowledge in defining directions and ways of implementing structural changes in Serbia;
- 4) Provide science based fundaments and projections for conducting more efficient economic policy in Serbia and processes of the EU integration;
- 5) Contribute to improving competitiveness of economic entities
- 6) Contribute to formulating measures for encouraging job creation, decrease unemployment, thus lowering social tensions
- 7) Provide 'benchmarking' of Serbia in the field of national branding and identify directions for repositioning of Serbia
- 8) Improve cooperation with scientific institutions in the EU countries and the region
- 9) Enable scientific and professional expertise and training to a greater number of researchers, first of all the younger ones.

The outcomes of the project will be science based results necessary for defining directions and ways of structural harmonization in the Republic of Serbia, which should serve as analytical and projection basis for decision making by state authorities and institutions, agencies as well as economic entities and other decision makers.

The project consists of five mutually connected thematic parts, as follows:

I – Evaluation of transition changes achieved so far and conditions in Serbian economy;

II – Macroeconomic framework for structural harmonization;

III - Restructuring of economic entities so as to increase business efficiency and effectiveness;

IV – Labor economy;

V – Improvement of competition and national identity of Serbia in order to encourage sustainable economic development.

Generally speaking, it can be concluded that within the project OI 179015 in 2011 higher level of scientific research was achieved if compared with the initially planned results. Namely, within this project, 43 researchers (from whom 28 are from the Institute of Economic Sciences of Belgrade) prepared 186 papers (recorded in relevant data bases such as COBISS, ISBN, ISSN and DOI) which total 493,5 credits according to the official quantification by the Ministry.

Researchers engaged in OI 179015 project published their papers in numerous national and international journals, conference proceedings, monographs, etc. Some papers were published in two international thematic monographs co-published by the Institute of Economic Sciences (whose publishing was funded from this project): "Serbia and the European Union: economic lessons from the new member states", which was published in Portugal in cooperation with the University of Coimbra and 'Contemporary Issues in the Integration Processes of Western Balkan Countries in the European

Union', which was published in Slovenia, in cooperation with the International Center for Promotion of Enterprises, Ljubljana.

Also, the research results have been published in scientific journals of the Institute, i.e. "Economic Analysis" and "Journal of Women's Entrepreneurship and Education – JWE", as well as in "Macroeconomic Analyses and Prognoses – MAP".

Finally, it is worth mentioning that the Institute created a separate space at out web page for presentation of goals, contents and the most important results of research at OI 179015 project.

#### 3. CONTEMPORARY BIOTECHNOLOGICAL APPROACH TO THE PROBLEM OF DRAUGHTS IN AGRICULTURE (TR – 31005, Head: Dr Radmila Stikić, Faculty of Agriculture, Belgrade

A number of the IES researchers has been engaged on the project of technological development titled **CONTEMPORARY BIOTECHNOLOGICAL APPROACH TO THE PROBLEM OF DRAUGHTS IN AGRICULTURE IN SERBIA** carried out by the Faculty of Agriculture, University of Belgrade. The project entails three subprojects, and the Institute of Economic Sciences has been engaged on the subproject No. 3 titled "Economic consequences of the draughts in agricultural production and competitiveness of produce on the market".

The macro project has been based on expertize and international cooperation established through realization of the three FP7 projects, with the plan to establish cooperation with the three additional institutions from the EU. The projects is aimed at suggesting technologies by using multidisciplinary approach which would increase resistance to draughts and efficiency in using water in production of important agricultural cultures.

The subproject **"Economic consequences of the draughts in agricultural production and competitiveness of produce on the market"** deals with determining economic consequences of the draughts on agricultural production using the climate change data, soil, agricultural surfaces, the type of plants, yields, availability of water, hydro conditions, etc. The results of the research would be used in creation of the GIS data base and mapping of the draught endangered areas in Serbia. The intention is to check the cost-effectiveness of durum production by doing economic analysis, since it is a culture more resistant to draughts than wheat. It is also intended to assess the economic effects of investment by doing cost-benefit analysis in terms of investing in new technologies and sorts and evaluating their social benefits.



The main aim of the international cooperation was preservation of the existing network of business partners and establishing new contacts in terms of strategic cooperation. With this regard, the existing bonds have been strengthened and new contacts were made with scientific, educational and public institutions throughout the region and Europe. Also, the Institute was the host to many renowned scientists, diplomats, businessmen and public servants. Associates of the Institute have been to study trips, visited renowned institutions at home and abroad, presented their research at international gatherings, managed and participated in the international projects. The following events best represent our international engagement.

# INITIATIVES

### SUMMER SCHOOL OF ECONOMICS (SSE)



Summer School of Economics 2011 was held on July 18-22 at the premises of the Institute of Economic Sciences. The summer course organized in 2011 is a part of a bigger project 'Summer School of Economics' which has been organized since 1998. The first Summer School was organized by Group 17. Traditionally, the languages of the Summer School are English as well as the languages of the south-slavic region (Bosnian, Croatian, Montenegrin, Serbian). The participants from Macedonia were asked prior to the commencement of the Summer School if they can follow lectures and discussions in the official languages. They responded positively, so that all lectures were held either in English or in the languages of former Yugoslav republics.

At this Summer School participated 29 carefully chosen candidates from Bosnia and Herzegovina – Republika Srpska (3%), Macedonia (7%), Montenegro (10%) and Serbia (79%). Also, students varied in terms of the university attended and the profile of their studies. The candidates were mainly students of economics and management, organizational science and political science.

Lectures were organized in a five-day course, from 9:00 a.m. till 5:15 p.m. The Institute of Economic Sciences provided students and the lecturers with all necessary equipment, such as lap-top computers, projectors, flip charts, etc. During this course there were 15 lectures given by professors from the country and abroad, experts and representatives of international organizations as well as the representatives of the Government bodies and National Bank of Serbia.



Upon completion of the lectures at the Summer School, the candidates were not obliged to sit the exam. Their work was assessed based on attendance and active participation in discussions during lectures. All candidates were given a certificate on successful completion of Summer School of Economics in 2011. Also, the candidates were given CDs containing PowerPoint presentations, handouts, photos and list of contacts with the names of all participants for the year 2011.

The aim of the RRPP is to improve research in the field of social science in the Western Balkans countries. The program has been realized through three mutually connected components as follows:

- Providing research grants to projects focused on transition in the region;
- Organization of the methodological and thematic seminars Establishment and strengthening of regional cooperation.

#### **RRPP Target groups:**

#### **Research institutions**

Public, private and public-private universities and independent research organizations which support regional integration and cooperation in order to improve their activities and practice in implementation of research in accordance with the European scientific standards. Partner institutions within the program have the opportunity to improve human resources, improve access to knowledge as well as to the regional and international networks.

#### Researchers

The program is focused on teaching assistants, professors, postgraduate students and PhD candidates. In order to contribute to reducing gender gap, the RRPP pays special attention to involvement of female researchers. The researchers are given a unique opportunity to gradually improve their research capacities through the program of trainings, knowledge approach, individual mentoring, funding as well as regional and international networking.

#### **Decision and policy makers**

Deans, chancellors and other representatives of relevant institutions are involved in the process of consultations and cooperation at the strategic level. They may have benefits from estimates, reports and research results carried out within the RRPP program.

#### Participation in the program:

Upon the invitation for submission of research project proposals, the researchers from the target countries submit their applications. The Scientific Board of the RRPP assesses the applications according to the special criteria and the general research subject previously defined during the consultations with the researchers from the mentioned countries. Upon their recommendation, the Steering Board takes a decision on funding the research projects. The researchers engaged on projects funded by the RRPP have the opportunity to attend methodology seminars, as well as present their research results at the international conference organized by the RRPP each year in one of the Western Balkans countries.

#### IES as RRPP LCU:

As the RRPP local coordination unit for Serbia, the Institute of Economic Sciences coordinates and monitors the projects funded within the program whose carriers are the research teams from Serbia, offering full support to research teams, organizing seminars and conferences in order to enhance research capacities of partner organizations, implements the initiative of establishing a dialogue

between the community of researchers and decision makers in order to introduce systemic measures as to improve the conditions in social science in Serbia.
